### ORDER

THIS MATTER coming before the Court (the Honorable Judge Michael F. Otto) on October 11, 2023 at 10:30 a.m. for in person hearing on Defendants' Combined Motion for Attorney's Fees and Costs and Motion to Impose Rule 137 Sanctions on Plaintiff (the "Combined Motion"), the Court having reviewed all briefs submitted by the parties, having heard oral argument and otherwise being advised in the premises;

## IT IS HEREBY ORDERED:

- (1) The Court finds that Defendants are entitled to a fee award under the Illinois Citizen Participation Act, but not Illinois Supreme Court Rule 137 or the Illinois Trade Secrets Act.
- (2) Based on the Illinois Appellate Court's ruling in *Midwest Rem Enterprises, Inc. v. Noonan*, 2015 IL App (1<sup>st</sup>) 132488, ¶¶ 87-88, the Court concludes that the decision of *Kroot v. Shu B. Chan*, 2019 IL App. (1<sup>st</sup>) 181392, ¶ 11-12 does not limit Defendants' fee award to the amount they have actually incurred.

- (3) The Court adopts the spreadsheet attached as Exhibit K of Plaintiff's Response to the Combined Motion, and the objections contained therein, and reduces the fee award to Defendants by \$7,072.50.
- (4) Pursuant to 735 ILCS 110/25, the Court enters a fee award in favor of Defendants and against Plaintiff in the amount of \$39,096.86.
- (5) A separate order has been entered simultaneously with respect to Plaintiff's Motion for Reconsideration, which was also argued at today's hearing.
